# 20 YEAR LIMITED WARRANTY

#### WHAT THIS LIMITED WARRANTY COVERS

TruNorth Composites Inc. warrants its products (the "SLIDE & GO FENCE") to be free from material defects in workmanship and materials, and shall not split, splinter, rot or suffer structural damage from termites or fungal decay for a period of twenty (20) years for Residential application. For purposes of this warranty, a "Residential application" shall refer to a single-family residential homeowner. This warranty is freely transferable to subsequent buyers of the property upon which the "SLIDE & GO FENCE" products were originally installed. This **LIMITED WARRANTY** is subject to the following conditions:

- This limited warranty applies only to "SLIDE & GO FENCE" that are both purchased and installed in Canada or the United States.
- 2. "SLIDE & GO FENCE" must be installed in accordance with the pre-approved design and installed in compliance with local building code requirements.

**FADE WARRANTY**: TruNorth Composites Inc. warrants that the product will not fade from original manufacturing colour with more than "Excessive Colour Fade." Tahoe Products warrants that the aluminum fence post and channels will not fade from original manufacturing colour with more than "Excessive Colour Fade." Excessive Colour Fade for the decking and powder coated aluminum is defined as fading by a colour change of more than 5 Delta E (CIE) units.

**STAIN WARRANTY:** TruNorth Composites Inc. warrants that the product will resist permanent staining from food and beverage items that may be spilled onto the surface of the product, including items such as condiments (barbecue sauce, ketchup, mustard, mayonnaise), salad dressing and salad oils, grease, tea, wine, coffee, fruit punch, sodas and other food and beverage related items that would typically be present near a residential fence, provided such substances are removed from the product with soap or water or mild household cleaners after no more than one (1) week of exposure of the substances to the surface of the product.

Notwithstanding the foregoing, TruNorth Composites Inc. does not warrant that the product is stain-proof, and does not warrant stain resistance resulting from spilled or otherwise applied food and beverage substances which are not properly cleaned as provided above within one (1) week of exposure. In addition, this warranty does not cover any staining or damage of the product resulting from abrasive compounds of acidic or basic Ph, paints or stains, strong solvents, metallic, rust or other abnormal residential fence use items, and non-food and non-beverage substances, including, but not limited to, biocides, fungicides, plant foods or other bactericides.

**Fencing Post Warranty:** The product is free from defects in material and workmanship in the course of manufacture and the finish on the Product will not chip, peel, flake or blister under conditions of ordinary use and wear for a period of 20 years commencing from the date of its purchase by the Owner, if installed and maintained according to the specifications and instructions of TruNorth's Slide & Go Fence Installation Guide.

This Warranty covers only genuine products of TruNorth Composites Inc. which are purchased by the Owner from an authorized Slide & Go Fence dealer. This Warranty does not cover damage of any kind resulting from: a) normal wear, tear, weathering and the damaging effects of sunlight and extremes of weather and atmosphere that may cause any surface to fade, chalk, or become soiled or stained; b) claimed defects, malfunctions or failures that result in whole or in part from abuse, misuse, neglect or improper installation, assembly or maintenance; c) accidental or intentional damage, collision, crash, impact of foreign objects or vandalism; d) settlement, structural shrinkage, distortion or expansion of the property, ground, or property structure; e) harmful or corrosive chemicals, including harmful cleaning compounds, sea or road salt, and pesticides, fumes, or vapors; f) surface deterioration due to air pollution, seacoast environment, airborne stains, mould, road salt, or mildew; g) warping or distortion due to exposure to excessive heat sources or exposure to unusual or excessive reflective heat sources;

h) cracking or crazing due to cold temperatures; and i) fire, lightning, flooding, hurricane, tornado, windstorm, earthquake, hail, other acts of God, or any other causes beyond the contemplation of TruNorth Composites Inc.

**TERM OF WARRANTY**: The term of this warranty shall begin on the date of original purchase and shall end twenty (20) years thereafter for Residential application. The warrantor will, at its option, either replace or refund the prorated portion of the purchase price as set forth in the "Prorated Refund Schedule" below for any defective "SLIDE & GO FENCE" products.

- 1. Improper product installation, non-conformance to local building code requirements, mechanical abuse, overloading, accidental and intentional damage, fire, hurricanes, lightning, hail, floods, earthquakes, tornado's, windstorms, excessive ice and other causalities or acts of God;
- 2. Damage resulting from movement and/or collapse of the ground or structure on which the products are installed;
- 3. Any other cause beyond the control of the manufacturer;
- 4. Ordinary wear and tear;
- 5. This limited warranty excludes changes in the appearance of SLIDE & GO FENCE resulting from mold, mildew, stains of any kind, chemicals, fertilizers, physical or mechanical abuse, moisture or other environmental factors unique to the products use or geographical location.
